SonixNet via NTT Optical Fiber is a high-speed internet service provided over NTT East Japan's public optical fiber broadband network, with an internet connection authenticated through JPNE's IPv6 IPoE, or NTTPC/IIJ's PPPoE. A visit by NTT to activate the required infrastructure and equipment during the installation is mandatory. Geographic restrictions apply. Contact Assist Solutions to see if you qualify.

Internet speed claims represent the theoretical maximum capability over the NTT optical fiber broadband connection. Actual customer speeds is provided at its best effort and are not guaranteed. User end speeds vary based on factors including site traffic, content provider server capacity, internal network management factors, and device capabilities.

Internet connection will not become active immediately after the NTT installation is completed. [For IPoE] The IPoE authentication requires up to 24 hours after the NTT installation is completed. Authentication will occur automatically. [For PPPoE] You will receive an email containing your username and password, and must configure your router or computer to access the internet.

Illegal activity on the internet, such as P2P sharing of copyrighted data, is strictly prohibited. Abusers can be detected and prosecuted by the Japanese law.

Customer must maintain a valid credit card and email address at all times. When cancelling, Assist Solutions require a notice of at least 10 business days in advance to the date of removal. Any rental equipment (NTT, router, etc.) must be returned immediately after cancellation of subscription. Failure to return the rental hardware may result in a compensation penalty.
